1 - The MCWD Wetland ID is associated with wetlands inventoried during the 2003 MCWD Functional Wetland Assessment (FAW). These wetlands are primarily located within the MCWD. However, there are a few wetlands in the other WMOs adjacent to the MCWD boundary that were inventoried as part of the 2003 MCWD FAW.

2 - For wetlands inventoried as part of the 2003 MCWD FAW that represent the same water body as in the City's 1991 wetland inventory, the WE from the 1991 inventory was preserved. Additionally, for wetlands included as part of the 2003 MCWD FAW that represent the same water body as in the City's 1991 wetland inventory but were not field assessed in 2003, the City's 1991 wetland management class and wetland type were preserved.

3 - As part of the 2003 MCWD FAW, several USFWS Circular 39 wetland types were often identified within the wetland with one being identified as dominant. For wetlands from the 2003 MCWD FAW, the first wetland type listed is the dominant wetland type.
